## PHARMACY AND POISONS ORDINANCE (Chapter 138)

## DIRECTION MADE BY THE DISCIPLINARY COMMITTEE OF THE PHARMACY AND POISONS BOARD OF HONG KONG

It is hereby notified that a Disciplinary Committee appointed by the Pharmacy and Poisons Board of Hong Kong under section 15 of the Pharmacy and Poisons Ordinance (Chapter 138, Laws of Hong Kong) to inquire into the conduct of an authorized seller of poisons, namely Ren Da Dispensary O/B Yan Tai Medicine Company Limited, at G/F Kam Lai Building, 5 Kai Man Path, Tuen Mun has conducted an inquiry on 22 April 2024 in accordance with section 16 of the Pharmacy and Poisons Ordinance.

The said Committee was satisfied after the inquiry that Ren Da Dispensary O/B Yan Tai Medicine Company Limited had been guilty of misconduct in that at the material time, Ren Da Dispensary O/B Yan Tai Medicine Company Limited was convicted of the following offences under the Pharmacy and Poisons Regulations (Chapter 138A, Laws of Hong Kong) made under the Pharmacy and Poisons Ordinance and the Trade Descriptions Ordinance (Chapter 362, Laws of Hong Kong) on the date specified below at Tuen Mun Magistrates' Courts for which the following orders were imposed:—

In addition, the said Committee was satisfied that Ren Da Dispensary O/B Yan Tai Medicine Company Limited had failed to comply with sections 1.4b, 2d, 2e, 2f and 3.3a of the Code of Practice for Authorized Seller of Poisons (2021 version).

It is further notified that under section 16(2)(b) of the Pharmacy and Poisons Ordinance, the said Committee directed that a warning letter be served on Ren Da Dispensary O/B Yan Tai Medicine Company Limited. The said Committee added that its direction should be published in the Government of the Hong Kong Special Administrative Region Gazette with an account of the proceedings.
